## AMERICAN CANOE ASSOCIATION MINOR WAIVER & RELEASE OF LIABILITY READ BEFORE SIGNING

IN CONSIDERATION of being permitted to participate in any way in the American Canoe Association, Inc. sports and recreation program and related activities ("Activities") I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of Paddlesports and related Activities and that I am qualified, in good health, in proper physical condition to participate in such Activity and willingly agree to comply with the stated and customary terms and conditions of participation. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity. If I decide to leave early and not complete the trip as planned, I assume all risks inherent in my decision to leave.

2. FULLY UNDERSTAND that: (a) Paddlesports and related ACTIVITIES INVOLVE RISKS AND DANGERS OF DAMAGE TO PERSONAL PROPERTY AND SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the minor in the Activity.

3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE American Canoe Association, Inc., its Paddle America Clubs, affiliated clubs and organizational affiliates, their respective ACA certified instructors, certified instructor trainers, and certified instructor trainer educators, administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, INJURIES, DAMAGE TO PROPERTY, OR OTHER DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.

**ASSUMPTION OF RISK AND GENERAL RELEASE OF LIABILITY  
AGREEMENT**

1. I recognize that the whitewater boating event that I am about to participate in is a rigorous and hazardous activity that may be physically and mentally stressful and may aggravate existing physical or mental conditions or cause new ones. I recognize that whitewater boating can be dangerous and that the dangers may include damage to or destruction of personal property, serious physical injury or even death arising from a variety of hazards including, but not limited to and by way of example only, rocks, trees, powerful waves, waterfalls, hydraulics and various other man-made or natural hazards and difficulty or improbability of rescue. I will have previously observed the Mokelumne River segments that are the subject of this event to determine for myself the nature and extent of the hazards that may exist. I acknowledge that, under these circumstances, the usual hazards associated with whitewater boating may be more unknown, uncertain, severe and dangerous. I also understand that during the course of this event, there may be significant variations in river flow that may alter the character of the river and the dangers and hazards of participating in this event.
2. I recognize that I am participating in this whitewater boating event:
  - a) for my own personal recreational purpose and not at the request of Pacific Gas and Electric Company;
  - b) that none of the other participants will be acting as a professional river guide for me;
  - c) I am not being compensated by Pacific Gas and Electric Company to engage in this activity;
  - d) that I am personally responsible for determining whether I have the skill and expertise to safely navigate any particular river segment; that I am solely responsible for selecting equipment suitable for use during this whitewater boating event; and, that no other person or entity associated with this whitewater boating event has any obligation to attempt to rescue me and that any attempted rescue may exacerbate my condition and cause injury or death.
3. ON BEHALF OF MYSELF, MY HEIRS, REPRESENTATIVES, EXECUTORS, ADMINISTRATORS AND ASSIGNS, I UNDERSTAND AND EXPRESSLY ASSUME ALL THE RISKS AND DANGERS INCIDENT TO THE WHITEWATER BOATING ON THE MOKELUMNE RIVER SEGMENTS INVOLVED AND HEREBY KNOWINGLY WAIVE AND RELEASE ALL CLAIMS INCLUDING, BUT NOT LIMITED TO, PROPERTY DAMAGE OR DESTRUCTION, PERSONAL INJURY OR DEATH, WHETHER CAUSED BY NEGLIGENCE, BREACH OF CONTRACT OR OTHERWISE, WHICH I MAY EVER HAVE AGAINST (A) PACIFIC GAS AND ELECTRIC COMPANY, AND THE UNITED STATES, AND ITS AFFILIATES, AGENCIES, EMPLOYEES, OFFICERS, DIRECTORS, AGENTS, ASSIGNS, REPRESENTATIVES AND SUCCESSORS, OR ANY OTHER PERSON OR ENTITY THAT MAY BE INVOLVED IN FACILITATING ANY USE AND ENJOYMENT OF THE MOKELUMNE RIVER SEGMENTS INVOLVED IN THIS EVENT; AND (B) EACH AND EVERY OTHER PARTICIPANT IN THIS WHITEWATER BOATING EVENT.
4. I represent that:
  - a) I am submitting this release and waiver voluntarily and of my own free will; I have no physical or emotional problems, nor any history thereof, which will impair my ability to participate in the activities of the proposed paddling event.
5. I recognize that neither Pacific Gas and Electric Company, nor its affiliates, representatives, officers, directors, employees, agents, successor or assigns are providing liability, health or other insurance in connection with this whitewater boating event and I agree to assume all financial responsibility for any medical, rescue or other expenses that I may incur and to defend, hold harmless and indemnify Pacific Gas and Electric Company, its affiliates, officers, directors, employees, agents, successors and assigns for any loss or damage, including attorneys' fees, that they may suffer should I pursue an action or claim that is waived or barred by this release and waiver.
6. I assume full responsibility for and agree to defend, hold harmless and indemnify Pacific Gas and Electric Company, and its affiliates, officers, directors, employees, agents, successors and assigns against claims, losses or judgments that may arise from any damage or harm that I may do or cause while participating in this whitewater boating event.

This waiver shall be binding upon me, my heirs, executors, representatives and administrators.
